## Steps You Can Take

## Engaging in conversation with your sphere of influence

We each have connections in the community as we navigate our daily lives. There are action items that we can take and
conversations we can have to ensure that we are providing safe environments. Below are some resources to equip you to have
meaningful conversations with your sphere of influence.

## School and Other Child-Serving Organization Actions

- Are you a parent who has a child in school? Do you currently attend, work, or volunteer in a school or other child serving organization? Ask your local school administrators if they have a safety plan for immigration actions on school property.
- Immigrant Legal Resource Center <u>Guide to School Safety Plans for Immigrant Children</u>: This resource provides guidance on action plans for schools and action steps for immigrant parents of school age children.
- United We Dream <u>Guidebook for Educators and School Support Staff</u>: Immigrant families, including their children, are
  navigating a number of difficulties that impact mental health and other facets of their daily lives. This guidebook is helpful to
  share with teachers and other staff members to help their immigrant students and also includes action items for school
  administrators.

### Place of Worship Actions

- Do you attend a place of worship or attend an activity that happens in a place of worship? Ask the leadership at your place of
  worship if they have discussed action steps in case of an immigration action or ways to equip faith members with accurate
  information on how to protect themselves.
- National Latino Evangelical Coalition Manual for Pastors & Church Leaders in Response to Executive Orders on
   Immigration: Places of faith are no longer spaces off limits to immigration enforcement. This manual highlights protections that can be made in a church buildings and steps to take during an immigration enforcement action.

### Places of Work Actions

- Does your workplace have a plan and policy if immigration officials come for an enforcement action? Have all staff been trained on the procedure?

  take precautions and develop a plan to know what to do if immigration officials come into the building and how to protect
  sensitive information. This guide discusses how to create a plan before an immigration action and what to do during an
  immigration enforcement action.

  items for health care centers and other medical offices to ensure a plan is in place to protect client information and patients in

# Steps You Can Take

## Know Your Rights

- Information is powerful, and it is essential that individuals know their rights in different settings. You can educate immigrants in your community about their rights.
- Having "Red Cards" available in different languages helps educate immigrants on their basic rights. Immigration Legal Resource Center has them available in different languages, <a href="here.">here.</a>

- Make sure to carry copies of valid documentation related to your immigration status, which could be a green card, work permit, visa, etc. Give copies of the original to someone in case it is needed. Don't carry documents from another country.

### Finding Legal Assistance

- Reputable legal assistance is important when navigating immigration legal concerns.
- Individuals should ensure that their legal representatives are knowledgeable about immigration law. Legal assistance should be received by someone who is licensed in immigration law or who is a Department of Justice (DOJ) accredited representative.
